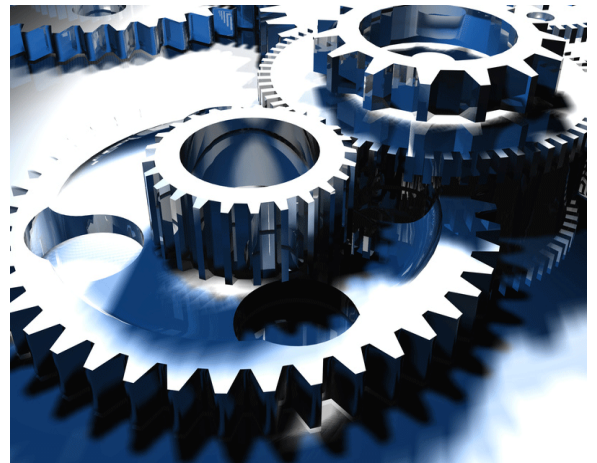

- Prior registration along with the Fee is a must.
- The number of delegates would be restricted to 20 on first come first serve basis.
- Delegate fee is not refundable. However, change in nomination is accepted subject to obtainability of travel document/arrangements.
- The last date to receive the registration along with payment is **5th September 2023**.

DELEGATE FEE

- The delegate fee is Rs. 2.75 Lakhs + 18% GST per delegate.
